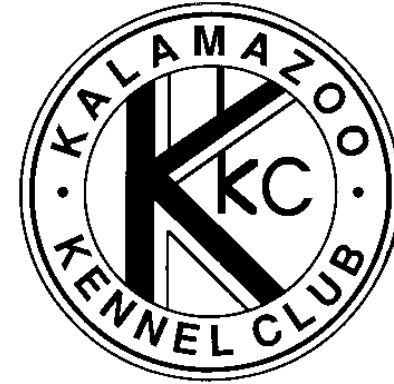

## Directions To Kalamazoo Kennel Club

From the North or South:  
US Hwy 131, Exit #44, East on D Ave:  
From the East or West  
I-94 to US Hwy 131 North to Exit #44, right (East) on D Ave:  
for all the above: going East on D Avenue, the Kennel Club is one Block past  
the 4 way stop at Douglas Ave.. The Kennel Club is the large white building  
on the right. If you go over the Kalamazoo River you have gone too far.

**Entries Close:** at 6pm on Wednesday, April 17, 2024. Drawing for entries  
and alternates will be on Wednesday, April 17, 2024 at 7pm at the Kalamazoo  
Kennel Club Building. 1249 West D Avenue, Kalamazoo, MI. All interested  
persons are welcome to attend.

Entries will be acknowledged after the closing date by a call or email and will  
receive a judging program.

**Entry fees** for alternates who do not participate in the test will be refunded.  
Entry fees for dogs that pass an AKC approved test after the closing date of  
this test will be refunded if they withdraw from this test, provided there is an  
alternate to replace the entry and the Test Secretary is notified in writing  
not less than 3 days before the test date.

**Trophies:** A rosette will be awarded to all passing dogs.

### Notice to Exhibitor

- **Entries** not on an official AKC entry form (or copy) including the waiver agreement are not acceptable.
- **TD Entries** must have a signed certification by an AKC Tracking Judge.
- Incomplete or illegible entries or those without correct fees cannot be accepted. Post-dated checks do not constitute a valid entry fee.
- **Owners** are responsible for errors in making out entry forms. No entry will be refunded in event of errors. No entry shall be accepted which specifies any conditions as to its acceptance.
- A \$25 service fee will be charged for returned checks.
- No telephone or FAX entries.
- **Canadian** exhibitors must make fees payable in **US FUNDS**.
- **All Express deliveries MUST** include signature waiver or may not be received.
- Only entries mailed to the Test Secretary's address will be accepted.
- **Kalamazoo Kennel Club** assumes no responsibility for cash sent through the mail.
- **Kalamazoo Kennel Club** may decline any entry or may remove any dog due to disease, viciousness, or other cause, and no one shall have any claim against Kalamazoo Kennel Club, or any official thereof.
- **ENTRY fees shall not be refunded;** in the event a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by action of the Test Committee. Or if because of riots, civil disturbances, or other acts beyond the control of the Test Committee, it is impossible to open or complete the test. Or in the event of extreme weather conditions.
- **Bitches in season** may participate in this test.

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons or trophies, I (we) agree to hold the AKC, the event giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event, and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITIONS OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICES AND GUIDELINES.

**INSTRUCTIONS**

- 1. (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color, black, ASCOB, parti-color), Beagles (not exceeding 13 in, over 13 in but not exceeding 15 in), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles, Poodles (toy, miniature, standard).
- 2. The Following categories of dogs may be entered and shown in Best Of Breed Competition: Dogs that are Champions of Record and dogs, which, according to their owners records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days form the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for a trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any trial for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to AKC. (For complete rules refer to Chapter 11, Section 3).
- 5. Mixed Breed Dogs should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
